# SUMMARY ANNUAL REPORT

This is a summary of the Annual Report for the Buffalo Laborers' Security Fund (the Fund), (Employer Identification No. 16-1605100 Plan No. 001) for the period July 1, 2020 to June 30, 2021.

The annual report has been filed with the Internal Revenue Service, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

## **BASIC FINANCIAL STATEMENT**

Benefits under the plan are provided by a trust (benefits are provided in whole from trust funds). Plan expenses were \$3,333,371. These expenses include \$168,184 in administrative expenses and \$3,165,187 in benefits paid to participants and beneficiaries. A total of 1,357 persons were participants in or beneficiaries of the plan at the end of the plan year.

The value of plan assets, after subtracting liabilities of the plan, was \$28,809,058 as of June 30, 2021 compared to \$24,408,952 as of July 1, 2020. During the plan year the plan experienced an increase in its net assets of \$4,400,106. The plan had total income of \$7,733,477. This income included employer contributions of \$2,841,637, net investment gain (loss) from registered investment companies of \$2,066,756, net investment gain (loss) from common collective trusts of \$1,984,768, interest on investments of \$80,769, dividends from registered investment company shares of \$747,371 and other income of \$12,176.
